SECTION 4 : FIRST AID MEASURES**Catalog No. L19158**

Eye Contact:	Immediately flush eyes with plenty of water for at least 20 minutes. Assure adequate flushing of the eyes by separating the eyelids with fingers. Get immediate medical attention if irritation persists, or symptoms of overexposure become apparent.
Skin Contact:	Immediately wash skin with plenty of water for at least 20 minutes, while removing contaminated clothing and shoes. Get medical attention especially, if irritation develops, persists, or symptoms of overexposure become apparent.

SECTION 7 : HANDLING and STORAGE**Catalog No. L19158**

Handling:	This product should be handled only by, or under the close supervision of, those properly qualified in the handling and use of potentially hazardous chemicals, who should take into account the fire, health and chemical hazard data. Engineering Controls:	Use appropriate engineering control such as process enclosures, local exhaust ventilation, or other engineering controls to control airborne levels below recommended exposure limits. Where such systems are not effective wear suitable personal protective equipment, which performs satisfactorily and meets OSHA or other recognized standards. Other Protective:	Facilities storing or utilizing this material should be equipped with an eyewash facility and a safety shower.
