Subacute to chronic toxicity:

Animal studies with EDTA salts have reported convulsions, weight loss, liver, kidney, ureter, and bladder changes. Fetotoxicity and developmental abnormalities have also been reported from studies on animals.

Additional toxicological information:

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
