Some organic phosphorus compounds are cholinesterase inhibitors. Symptoms associated with these include muscle twitching, convulsions, flaccid paralysis, coma, respiratory failure. They can be highly paralytic.  
 Oxidation of ruthenium/ruthenium compounds may form the volatile and highly irritating ruthenium (VIII) oxide.
