Those exhibiting substantial water reactivity will have stronger irritating properties and may be corrosive enough to cause severe burns. Some organic phosphorus compounds are cholinesterase inhibitors. Symptoms associated with these include muscle twitching, convulsions, flaccid paralysis, coma, respiratory failure. They can be highly paralytic. Subacute to chronic toxicity: No effects known.
