4.1. Description of first aid measures

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Hydrogen bromide (HBr). Hydrogen chloride (HCl).

5.3. Advice for fire-fighters
