### 4.1. Description of first aid measures

**Eye contact:** Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to hospital as soon as possible.
