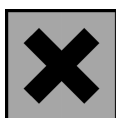

4.1. Description of first aid measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Hydrogen fluoride (HF).

5.3. Advice for fire-fighters

Advice for fire-fighters: Cylinder may explode under conditions of fire. Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes. Keep cylinders cool with water spray.

6.1. Personal precautions, protective equipment and emergency procedures

Personal precautions: Refer to section 8 of SDS for personal protection details. If outside do not approach from downwind. If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid.
