4.1. Description of first aid measures

4.2. Most important symptoms and effects, both acute and delayed

Skin contact: There may be irritation and redness at the site of contact. May cause sensitization by skin contact.

Eye contact: There may be irritation and redness. The eyes may water profusely.

Ingestion: There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur. There may be vomiting. harmful if swallowed

Inhalation: There may be irritation of the throat with a feeling of tightness in the chest.

Section 5: Fire-fighting measures

5.1. Extinguishing media
