4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin.

Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist

oxygen if available. Transfer to hospital as soon as possible.
