2. HAZARDS IDENTIFICATION

Main hazards: Toxic by inhalation, in contact with skin and if swallowed.

3. COMPOSITION / INFORMATION ON INGREDIENTS

Hazardous ingredients: 5-BROMO-2-FLUOROANILINE >90%

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be redness or whiteness of the skin in the area of exposure. Irritation or pain may

occur at the site of contact. Absorption through the skin may be fatal.

Ingestion: Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to

drink immediately. If unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. Transfer to

hospital as soon as possible.

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure

the casualty sits or lies down. If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to

hospital as soon as possible.

5. FIRE-FIGHTING MEASURES
