4.1. Description of first aid measures

on skin. Transfer to hospital if there are burns or symptoms of poisoning.

Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist

examination.

Ingestion: Do not induce vomiting. Wash out mouth with water. Give 1 cup of water to drink every 10

minutes. If unconscious, check for breathing and apply artificial respiration if necessary.

4.2. Most important symptoms and effects, both acute and delayed

Skin contact: Severe burns may occur. Blistering may occur.

Eye contact: There may be severe pain. The eyes may water profusely. Corneal burns may occur. May

cause permanent damage.

Ingestion: Corrosive burns may appear around the lips. Nausea and stomach pain may occur.

There may be vomiting.

Inhalation: There may be shortness of breath with a burning sensation in the throat. There may be

tightness of the chest.
