2.1. Classification of the substance or mixture

4.1. Description of first aid measures

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Hydrogen bromide (HBr).

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.
