### 2. HAZARDS IDENTIFICATION

**Main hazards:** Irritating to eyes, respiratory system and skin.

### 3. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** 2-HYDROXY-2-METHYL-N-[4-NITRO-3-(TRIFLUOROMETHYL)PHENYL]PROPANAMIDE
