Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used.

Exposure hazards: In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Nitrogen oxides (NO_x). Hydrogen chloride (HCl).
