**Extinguishing Media**

**Suitable**

foam, dry extinguishing powder, carbon dioxide (CO<sub>2</sub>), water spray jet

**Hazards During Fire-Fighting**

toxic fumes

Wear a self-contained breathing apparatus and chemical protective clothing.
