#### Description of Necessary First Aid Measures

#### **For Non-Emergency Personnel: (cont.)**

Product is moisture sensitive and releases flammable gases when exposed to moisture and water. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). ### Section 7. Handling and Storage

**Precautions:**

Product is moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Avoid formation and inhalation of dusts and aerosols. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

**Protective Measures:**

Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

**General Occupational Hygiene:**

**Environmental Exposure Controls:** Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. #### Individual Protection Measures

##### **Hygiene Measures:**
