Unusual Fire and Explosion Hazards: This material reacts with water and compounds containing active hydrogen such as alcohols and acids to produce flammable liquids and gases. Engineering Controls:

Properly operating explosion-proof, chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

Environmental Exposure Controls:
