### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

**General Advice:** Move out of dangerous area. Consult a physician. Show this safety data sheet to the doctor in attendance.

**Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue rinsing. Seek medical attention if eye irritation develops and persists.

- Suitable Extinguishing Media:** THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO<sub>2</sub>) may also be used.
- Unsuitable Extinguishing Media:** DO NOT USE WATER OR FOAM as product reacts to produce extremely flammable vapors upon contact with water.

### Section 6. Accidental Release Measures

**Small Spill:**

### Section 7. Handling and Storage

**Precautions:**

Product is moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation of aerosols and the inhalation of sprays, mists, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

**Protective Measures:**

#### Safe Storage Conditions:

Product is air and moisture sensitive; store under an inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Store refrigerated at 2 – 8 °C. Keep away from all sources of ignition – NO SMOKING. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

#### Engineering Controls:

#### Eye/Face Protection:
