Collect dust using a vacuum cleaner equipped with HEPA filter. This product is miscible in water. Prevent entry into waterways, sewer, basements or confined areas. Stop the flow of material, if this is without risk.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. For waste disposal, see section 13 of the SDS. Small Dry Spills: With clean shovel place material into clean, dry container and cover loosely; move containers from spill area.
