Methods and materials for containment and cleaning up Stop the flow of material, if this is without risk. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Minimize dust generation and accumulation. Following product recovery, flush area with water. For waste disposal, see section 13 of the SDS.
