#### 4. **First Aid Measures**

<b>Eye Contact:</b>	Check for and remove any contact lenses. Immediately flush eyes with clean, running water for at least 15 minutes while keeping eyes open. Cool water may be used. Seek medical attention.

#### 6. **Accidental Release Measures**
