### 4. First Aid Measures

After contact with skin, wash with generous quantities of running water. Gently and thoroughly wash affected area with running water and non-abrasive soap. Cool water may be used. Cover the affected area with emollient. Seek medical attention. Wash any contaminated clothing prior to reusing.
<b>Inhalation:</b>	Remove the victim from the source of exposure to fresh, uncontaminated air. If victim's breathing is difficult, administer oxygen. Seek medical attention.
<b>Ingestion:</b>	Do NOT induce vomiting. Give water to victim to drink. Seek medical attention.

## 5. **Fire-Fighting Measures**

<b>Extinguishing media:</b>	Carbon dioxide, dry chemical powder, alcohol or polymer foam.
<b>Special fire fighting procedures:</b>	Wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.

## 6. **Accidental Release Measures**

---

Steps to be taken if material is spilled or otherwise released into the environment - Wear Appropriate respirator, impervious boots and heavy rubber (or otherwise impervious) gloves.
