



**4. FIRST-AID MEASURES**

<b>Skin contact:</b>	Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.
<b>Eye contact:</b>	Move victim to fresh air. Check for and remove any contact lenses. In case of contact with substance, immediately flush eyes with running water for at least 20 minutes. <b>Ingestion:</b>	If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Loosen tight clothing such as a collar, tie, belt or waistband. If swallowed, seek medical advice immediately and show the container or label. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves. Effects of exposure (ingestion) to substance may be delayed.
