# 4. FIRST-AID MEASURES

Inhalation: Skin contact:	Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed. Suitable extinguishing media:	Dry chemical, soda ash, lime or dry sand. Consult with local fire authorities before attempting large scale fire fighting operations.

### Special precautions for fire-fighters:

Use water spray or fog; do not use straight streams. Dike fire-control water for later disposal; do not scatter the material. CAUTION: All these products have a very low flash point: Use of water spray when fighting fire may be inefficient. Do not use straight streams. Runoff to sewer may create fire or explosion hazard. May re-ignite after fire is extinguished. Do not get water inside containers. Cylinders exposed to fire may vent and release gasses through pressure relief devices. ### 6. ACCIDENTAL RELEASE MEASURES

### Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Do not direct water at spill source. DO NOT get water inside container. All equipment used when handling the product must be grounded. Absorb with DRY earth, sand or other noncombustible material. Use clean non-sparking tools to collect material and place it into loosely covered plastic containers for later disposal. Do not cleanup or dispose except under supervision of a specialist.
