4. FIRST-AID MEASURES

Inhalation: Call emergency medical service. Move victim to fresh air. Give artificial respiration if victim is not breathing.

Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and

supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to

protect themselves.

Skin contact: Call a poison center or doctor if you feel unwell. In case of contact with substance, immediately flush skin

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

7. HANDLING AND STORAGE

Precautions for safe handling: Avoid inhalation of vapor or mist. Avoid contact with skin and eyes. DO NOT expose to friction or

mechanical shock. Avoid formation of dust and aerosols. Keep away from heat and sources of ignition. Use explosion-proof equipment. Use only non-sparking hand tool when handling this product. Ground all equipment containing material. Take measures to prevent build up of electrostatic charge. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink,

or smoke. Keep away from sources of ignition.
