In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area.
