# 4. FIRST-AID MEASURES

Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not Inhalation:

# 6. ACCIDENTAL RELEASE MEASURES

Personal protective equipment: Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Dust

respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves

Prevent dust cloud. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the **Emergency procedures:**
