Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Personal protective equipment:	Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).		
Emergency procedures:	Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.		

### Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

Precautions for safe handling:	Do NOT breath gas, fumes, vapor, or spray. Manipulate under an adequate fume hood. Avoid contact with skin and eyes. Keep away from heat and sources of ignition. Use explosion-proof equipment. Use only non-sparking hand tool when handling this product. Ground all equipment containing material. Take measures to prevent build up of electrostatic charge.
