4. FIRST-AID MEASURES

Inhalation: Call a poison center or doctor if you feel unwell. Move victim to fresh air. Give artificial respiration if victim

is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat

symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and

take precautions to protect themselves.

Skin contact: If skin irritation occurs get medical advice/attention. Remove and wash contaminated clothing before reuse. In case of contact with substance, immediately flush skin with running water for at least 20 minutes.

Ingestion:Do not induce vomiting with out medical advice. If swallowed, seek medical advice immediately and show the container or label. Do not use mouth-to-mouth method if victim ingested the substance; give artificial

respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. 5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up:

7. HANDLING AND STORAGE
