Personal precautions:	Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. # Methods and materials for containment and cleaning up:

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. **Environmental precautions:**
