4. FIRST-AID MEASURES

Eye contact:

Call emergency medical service. Move victim to fresh air. Give artificial respiration if victim is not breathing. Inhalation:

Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and

supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to

protect themselves.

Skin contact: Call a poison center or doctor if you feel unwell. Remove and wash contaminated clothing before re-use.

Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves. IMMEDIATELY flush eyes with running water for at least 15 minutes, keeping eyelids open. Contact with

material may irritate or burn eyes. Call emergency medical service. Move victim to fresh air. Check for and remove any contact lenses. Keep victim warm and guiet. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat

ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers,

basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. Dike far ahead of spill; use dry sand to contain the flow of material. **Environmental precautions:**

Environmental hazard. Do not let product enter drains. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.
