4. FIRST-AID MEASURES

Inhalation: Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not

breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically

and supportively. Ensure that medical personnel are aware of the material(s) involved and take

precautions to protect themselves.

Skin contact: Immediately call a poison center or doctor. Remove and wash contaminated clothing before re-use. In

Ingestion: Toxic if swallowed. Do not induce vomiting with out medical advice. If swallowed, seek medical advice

Do not use mouth-to-mouth method if victim ingested the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: Dry chemical, CO₂ or water spray. Consult with local fire authorities before attempting large scale fire

Specific hazards arising from the chemical

Hazardous combustion products: These products include: Carbon oxides Sulfur oxides Other specific hazards: Closed containers may explode from heat of a fire.

Special precautions for fire-fighters:

Use water spray or fog; do not use straight streams. Dike fire-control water for later disposal; do not scatter the material. CAUTION: All these products have a very low flash point: Use of water spray when fighting fire may be inefficient. Do not use straight streams. Runoff to sewer may create fire or explosion hazard. 6. ACCIDENTAL RELEASE MEASURES

Emergency procedures:

Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.
