4. FIRST-AID MEASURES

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Do not direct water at spill source. DO NOT get water inside container. All equipment used when handling the product must be grounded. Absorb with DRY earth, sand or other noncombustible material. Use clean non-sparking tools to collect material and place it into loosely covered plastic containers for later disposal. Do not cleanup or dispose except under supervision of a specialist.
