6. ACCIDENTAL RELEASE MEASURES

Personal precautions:	Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use spark- proof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn
Personal protective equipment:	unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel. Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor respirator. Emergency procedures:

Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area.
