4. FIRST-AID MEASURES

Inhalation: Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not

breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take

precautions to protect themselves.

Immediately call a poison center or doctor. Remove and wash contaminated clothing before re-use. In Skin contact:

6. ACCIDENTAL RELEASE MEASURES

area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. **Environmental precautions:**

Keep away from living quarters. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.
