4. FIRST-AID MEASURES

Inhalation:	Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed. Inhalation of vapors or contact with substance will result in contamination and potential harmful effects. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. 6. ACCIDENTAL RELEASE MEASURES
