Personal precautions:	Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use spark- proof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Methods and materials for containment and cleaning up:
