4. FIRST-AID MEASURES

Eye contact:

Inhalation: Call a poison center or doctor if you feel unwell. Move victim to fresh air. Give artificial respiration if victim

is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat

symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and

Skin contact:

Call a poison center or doctor if you feel unwell. Remove and wash contaminated clothing before re-use.

Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately

flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves. IMMEDIATELY flush eyes with running water for at least 15 minutes, keeping eyelids open. Contact with material may irritate or burn eyes. Call emergency medical service. Move victim to fresh air. Check for and remove any contact lenses. Keep victim warm and quiet. Treat symptomatically and supportively. Effects of

Ingestion: Harmful if swallowed. Do not induce vomiting with out medical advice. Call a physician or Poison Control

Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the

Methods and materials for containment and cleaning up:
