Personal precautions:

Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use sparkproof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk.
