Personal precautions:

Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area.
