4. FIRST-AID MEASURES

Skin contact:

Inhalation: Call a poison center or doctor if you feel unwell. Effects of exposure (inhalation) to substance may be

delayed. Inhalation of vapors or contact with substance will result in contamination and potential harmful effects. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ingestion: Effects of exposure (ingestion) to substance may be delayed. If swallowed, seek medical advice

immediately and show the container or label. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical

personnel are aware of the material(s) involved and take precautions to protect themselves.

6. ACCIDENTAL RELEASE MEASURES

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. **Environmental precautions:**

Keep away from living quarters. Do not let product enter drains. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.
