# 4. FIRST-AID MEASURES

Skin contact:

Inhalation: Call a poison center or doctor if you feel unwell. Effects of exposure (inhalation) to substance may be

Ingestion: Effects of exposure (ingestion) to substance may be delayed. If swallowed, seek medical advice

immediately and show the container or label. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. #### 6. ACCIDENTAL RELEASE MEASURES

Keep away from living quarters. Do not let product enter drains. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

## 7. HANDLING AND STORAGE
