4. FIRST-AID MEASURES

Eye contact:

Inhalation: Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not

breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take

precautions to protect themselves.

Skin contact: Immediately call a poison center or doctor. Remove and wash contaminated clothing before re-use.

Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. 6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. **Environmental precautions:**
