4. FIRST-AID MEASURES	
Inhalation:	Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed. Move victim to fresh air. Give artificial respiration if victim is not breathing. Ingestion:	Do not induce vomiting with out medical advice. Call a physician or Poison Control Center immediately. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

6. ACCIDENTAL RELEASE MEASURES Personal protective equipment: Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile). Emergency procedures: Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Methods and materials for containment and cleaning up:
