4. FIRST-AID MEASURES

Inhalation:	Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed. Move victim to fresh air. Give artificial respiration if victim is not breathing. Methods and materials for containment and cleaning up:
