### Ecological Information

Ecotoxicity

Environmental Fate

Diethyl hydrogen phosphite (DEHP) may be produced in significant quantities, although no data are available. DEHP is used as a paint solvent, lubricant additive, antioxidant, reducing agent, intermediate in flame retardants and insecticides, and as a phosphorylating agent. It is not known how much or in what way DEHP is released into the environment. In soil, DEHP will probably hydrolyze and leach into groundwater (where it will completely hydrolyze). In water, DEHP will hydrolyze but will not evaporate readily nor sorb to sediments or biota. It is not known whether DEHP biodegrades. Photolysis may occur, although no rates are available.
