# 4. FIRST-AID MEASURES

# 5. FIRE-FIGHTING MEASURES

### Specific hazards arising from the chemical

#### Special precautions for fire-fighters:

Use water spray or fog; do not use straight streams. Dike fire-control water for later disposal; do not scatter the material. ### 6. ACCIDENTAL RELEASE MEASURES

Personal precautions:	Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use spark- proof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away.
