4. FIRST-AID MEASURES

Eye contact:

Ingestion:

Inhalation: Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed.

Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is

difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

Do not induce vomiting with out medical advice. Call a physician or Poison Control Center immediately. Loosen tight

clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and guiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and

take precautions to protect themselves.

Emergency procedures:

In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. Ventilate the area. **Environmental precautions:**

7. HANDLING AND STORAGE
