4. FIRST-AID MEASURES

Eye contact:

Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed. Inhalation:

Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and
